On 10/1/2014 at approximately 2300 hours, I responded to 1262 NW 14th Street in reference to a suspicious incident.

Upon arrival, I met with the complainant and Fort Lauderdale Police Detective, Steve Smith, who advised he has been receiving text messages for the past several months from a W/M, Michael Osburn. Osburn was under surveillance by Smith recently due to Osburn's threats against police via social media. Osburn was recently placed into custody under the provisions of the Baker Act. While Osburn was in custody, Smith routinely called the psych ward for updates on his release status. When Osburn was released, he requested the names and phone numbers of anyone that inquired about him. The nurse at the psych ward gave out Smith's number. Since then, Smith has received harassing text messages and advised Smith that he knows he lives in Boca Raton.

Smith has reported this to Fort Lauderdale Police. FLP will be attempting to make contact with Osburn in the near future. Smith just wanted to file a report and make Boca PD aware of the situation. Extra patrols will be conducted.
