
PROBABLE CAUSE AFFIDAVIT

Before be this date personally appeared **D. Miller** who being first duly sworn deposes and says that on the **1** day of **October, 2014** at **1300 W Broward Blvd** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe same are as follows:

The Def. in this case has engaged in consistent harassment of the victim over a period of time, dating back to August 2014. The victim in his case is a Detective with the Ft. Lauderdale Police Department and conducted an investigation in to the Def., after learning that the Def. had made general threats to kill police officers and harm himself and others. The initial investigation resulted in the Def. being Baker Acted for the safety of the community. (See Case # 14-73105)

Eventually, the Def. was released from the Baker Act assessment and due to an oversight, was provided the victim's personal cell phone number by a staff member of Broward Medical Center. As a result, the Def. has been sending the victim text messages, with varying degrees of hostility over the course of nearly 3 months. Where-as, the Def.'s initial threats posted via social media and other outlets had been directed toward police in general, the Def. seemed to now be focused on the victim in this case. The victim has received 20-30 text messages from the Def.



Before me this date personally appeared **Det. D. Miller** who being first duly sworn deposes and says that on the 2 day of **October, 2014** at **1300 W Broward Blvd** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe same are as follows:

The victim, due to his own fear of being targeted by the Def, has consistently responded to the Def. to stop texting him; informing the Def. that he is not who he thinks he is, that the victim does not know him and to leave him alone. The Def. has still continued contacting the victim. The Def. has even sent pictures of himself to the victim, identifying himself.

The Def. has also created a personal webpage where he references the victim by name. Screen shots and print outs have been obtained of the website; however, The Def. also posted links to photos of the text messages he sent to the victim. His website was shutdown (presumably by the Def) on 10/2/2014 and those files are not recoverable at this time. The Def. has also posted numerous Facebook posts of threatening nature, stating "I WANT THEM DEAD" when referring to FBI agents; also, "IF ANY OF THEM TRY TO APPROACH ME AGAIN, I WILL KILL THEM" [referring to FLPD after being trespass warned].


The Def. has taken pictures of vehicles located in police parking lots and sent the victim the pictures, asking if it is the victim's car. The Def. has also come to the victim's place of work (Ft. Lauderdale Police Station) without legitimate reason or purpose and has been witnessed "casing" the parking lot. As a result, he has been stopped and officially trespassed warned from the property, if he is not here for legitimate purposes.

All of these incidents have culminated in to texts sent by the Def. to the victim on 10/1/2014. The texts stated the following: "I want porky pigs name, the fat one with the mole on his cheek [...] When I find them they will cease to breathe, I know where you live...somebody's watching you. Pay your insurance...not too bright pretty boy." "In the name if self defense...luttuce pray". The Def. then named the city in which the victim lives (purposefully withheld in this document).

The Def. has displayed an obvious course of conduct and pattern of behavior over time spanning months. The Def. has continued to harass the victim and caused substantial emotional stress to the victim. Based on the 10/1/2014 text messages, the Def. has made credible threats via direct electronic communication to the victim, citing the fact that people would "cease to breathe", while at the same time referencing the victim's city of residence and that someone is watching the victim. This threat has placed the victim in reasonable fear for his safety and the safety of his family. Based on the displayed intimate knowledge of the victim by the Def., he has demonstrated an apparent ability to carry out the threats. The victim desires prosecution in this case and will be obtained a restraining order as a result of these most recent threats.

On 10/2/2014 the FLPD Career Criminal Unit was notified that Probable Cause existed for the arrest of the Def. for Aggravated Stalking. During the morning hours of 10/2/2014 Detectives observed the Def. leave his residence on his bicycle. The Detectives activated their police lights and sirens in their unmarked vehicle and affected a stop of the Def. The Detectives exited in police tactical uniforms with badges displayed and ordered the Def. to the ground via loud, verbal commands. The Def. refused their commands and was forcefully taken to the ground, at which time he was informed to "Stop Resisting". The Def. tensed and braced, fighting the officers' efforts to place this hands behind his back and handcuff him. The Def. was eventually detained and taken into custody.
